

# AQUA SPA

## Aqua Spa House Rules:

- The pools and sauna world are open to guests of the hotel from 7 am; for visitors not staying at the hotel, access is open from 10 am. The Spa closes at 10 pm. Admission closes at 9 pm. Please bring the towels from your hotel room while visiting Aqua Spa
- Persons under the age of 16 are not allowed to the Aqua Spa without being accompanied by a parent or adult guardian.
- Children up to 7 years old (inclusive) may be present at the dressing rooms and shower rooms of the opposite sex.
- Before swimming or visiting the sauna, please wash yourself carefully without swimwear.
- We recommend that you tie up your hair or wear a swimming cap.
- Swimwear must be worn at the pools and in sauna area.
- When moving from a sauna to the pool or a jacuzzi, please shower first.
- Please select a swimming facility in accordance with your skills and health condition. Please be mindful of yourself as well as others.
- Jumping into pools is not permitted.
- Children under 6 years old may not be in pools without an adult. Children must not be left unsupervised.
- The children's pool has been roughened to avoid slipping. The hotel shall not be liable for ruined or damaged swimwear.
- It is prohibited to throw drinks, drinking straws, cigarettes and other objects into the pool.
- Please move at a calm pace at the spa; do not run. Floors may be slippery when wet!
- Shaving and dyeing one's hair is not allowed in the shower room.
- It is prohibited to use body scrubs, honey, etc., and to use sauna whisks in the saunas.
- In the sauna, only throw water on to the dry rocks and be mindful of others.
- Do not leave your wristband and valuables unattended. The hotel shall not be held liable for items left in the dressing rooms. Please use the mini-safes at the Aqua Spa reception for storing your valuables.
- Aqua Spa has video surveillance.
- It is prohibited to consume brought-along snacks and drinks in the Aqua Spa sauna and pool area. Drinks are available for sale at the Aqua Spa bar. In accordance with legislation, when in doubt, the bar attendants have the right to ask for the personal identification documents of any guest wishing to purchase an alcoholic beverage.
- Tallink Spa & Conference Hotel shall not be held liable for injuries or medical episodes of any guests, nor shall it cover the resulting damages.
- In case of damage or loss of a wristband, a penalty of 50 EUR must be paid.
- Smoking or being under the influence of a narcotic substance or under the strong influence of alcohol at the Aqua Spa is prohibited. The staff has the right to deny access to the Aqua Spa to any guests in such a condition, or to end the validity of a ticket of a guest in such a condition, and to ask them to leave.
- A penalty of 60 EUR is foreseen for prohibited activities and disturbing the peace of one's fellow guests.
- A valid Club One card must be always presented before the performance of a purchase. Aqua SPA reception shall not retroactively set the discounts available with the card.
